

GreenWay construction notice

Johnson Park partial temporary closure

from 26 August 2024 to May 2025

The GreenWay is a major pedestrian, cycling, and biodiversity corridor linking the Cooks River at Earlwood with the Parramatta River at Iron Cove. As part of the GreenWay project, Johnson Park will also undergo some improvements. The improvements will require closure of the park in two stages. A partial closure of the park will commence on 26 August 2024 and remain in place until May 2025 (pending weather delays). A future full closure of the park will commence from November 2024 to May 2025 (pending weather delays) and further details of this full closure will be provided closer to the date.

Where will the partial closure be undertaken?

Access to the southern section of the field within Johnson Park will be closed from 26 August 2024 until May 2025 (pending weather delays). This includes part of the off-leash dog area. Alternative off-leash dog parks can be found on council's website innerwest.nsw.gov.au/ActiveInnerWest.

What type of work is being done?

The partially closed area of the field will be used for material storage in preparation for and during the Johnson Park upgrades. The upgrades will consist of a new playground, new multipurpose court, footpaths, planting, seating, and lighting.

What will be the pedestrian access through Johnson Park?

No new pedestrian detours are required.

To minimise impact on residents and other park users, the new partial field closure will follow a similar arrangement to the existing site compound fencing and vehicular access gates currently being implemented at the north side of Constitution Road tunnel, adjacent Arlington Light Rail stop. This allows continued use of the existing pedestrian paths. The contractor will manage pedestrians in the area during any vehicle crossings.

When will the work be undertaken?

The first stage partial closure will commence from 26 August 2024 and remain in place until May 2025 (pending weather delays). Works are planned to take place during regular working hours 7am – 6pm on weekdays.

What will be done to minimise inconvenience for me?

Every effort will be made to minimise noise associated with the movement of vehicles, plant, and equipment. The contractor will undertake mitigation measures in accordance with their Construction Environmental Management Plan to reduce noise, dust, and debris during their works.






